To be better prepared for the environmental and health hazards involved with certain chemicals, the European chemicals legislation has been re-organised in the REACH and GHS regulations.

**REACH** (Registration, Evaluation and Authorization of CHemical substances) ensures awareness of the characteristics of chemical substances and their registration on the European market. REACH thus also contributes to the replacement of substances of very high concern by safer chemicals, as these substances of very high concern must pass an authorisation procedure.

The **GHS** regulation (Globally Harmonised System of Classification and Labelling of Chemicals) governs the standardised classification and labelling of chemical substances and mixtures. Dangerous substances and mixtures may be re-classified and identified by new, standardised picto-

grams and safety phrases on their outer packaging. Consequently, all safety data sheets will have to be changed.

REACH and GHS shift most of the responsibility for the safe handling of chemicals from the regulatory bodies to producers, importers and downstream users and retailers. The relevant requirements and consequences, however, are not clear at first sight.

## REACH — Made easy with TÜV SÜD expertise.

Since December 2008, the pre-registration period for chemicals under REACH has expired. Chemicals now must be registered within transition periods with the "European Chemicals Agency" (ECHA) depending on their volume and hazardous properties.

Producers and importers who have preregistered their substances benefit from more time for the actual registration and can place their substances on the market without interruption. Substances that have not been (pre)-registered, by contrast, may only be placed on the EU market in quantities of under one tonne per calendar year.

Within the scope of mandatory registration and communication, the companies concerned must fulfil their duties to communicate detailed information down the supply chain. The aim pursued by these measures is to collect the relevant information and efficiently identify hazards. Recommendations concerning risk management measures, for example, also must be communicated.

The REACH regulation is highly complex. It includes a host of exemptions and special provisions. The number of aids and tools published by the EU to assist REACH implementation is also growing constantly.

To assist the companies affected by REACH, TÜV SÜD has established an international REACH network. Our environmental experts are tracking REACH implementation in the EU on an ongoing basis. ## GHS — Clear classification and safe labelling of chemicals.

With the GHS Regulation now effective, the worldwide UN system for the classification and labelling of substances and its transitional arrangements now also applies in Europe. It replaces the system in accordance with the substances and preparation directive. All substances must have been re-classified and labelled by 1 December 2010, and all mixtures by 15 June 2015.

In addition, similar to REACH, the GHS Regulation specifies comprehensive duties of communication along the supply chain. Many of the mandatory substance assessments, in particular in toxicology and ecotoxicology, must be expressly carried out by experts. In addition to the gradual preparation of new safety data sheets, increased attention must also be paid to supply and production safety, as there are manifold impacts on related legal disciplines, including transport, dangerous goods and hazardous incident law or occupational health and safety. GHS concerns all processes associated with the handling, storage, transport and use of chemicals.

GHS and REACH implementation is complex and closely interlinked. Avoid incorrect implementation and prevent unnecessary delays. Our chemical law experts will be happy to advise you.


